JERSEY STEWARDS' REPORT

11 August 2019

Stewards: Chief Steward, Michael Shenkin; Steward's Panel Chair, Simon Vivian; Stewards, Thady Griffith, Gordon Shenkin, Jacob Shenkin; Trainee Steward Lizzie Bois.

Going: Good, good to firm in places

Fixture Note: The Veterinary Officer reported that equine influenza vaccinations for **MOLLIANA** and **HIDDEN DEPTHS**, trained by Neil Mulholland, were not within the 6 month time limit imposed by the Rules (**MOLLIANA** by 3 days and **HIDDEN DEPTHS** by a month and a half). The Veterinary Officer reported that in his opinion the lapse did not cause any measurable risk. The Stewards noted that the British Horseracing Authority had amended the period between vaccination to 8 months in May 2019. The Stewards considered the Veterinary Officer's advice and exercised their discretion under Rule (E) 17.7.1 to allow both horses to run. Mr Mulholland was reminded that different rules currently apply in the Channel Islands to the UK.

Prior to Racing: **WOLF HUNTER** in second race was selected for routine testing.

Mrs Corson requested that **LITTLE LOTTIE** in the third race and **RAINBOW CHARLIE** in the fifth race do one loop of the parade ring and be released to post.

Mrs Malzard requested **SAFIRA MENINA** in the third race be mounted on the course.

The requests were granted.

Race 1 - 2.30pm. LADBROKES - WHERE THE NATION PLAYS HANDICAP HURDLE

Nothing to report.

Race 2 - 3.05pm - LADBROKES - BET STATION HANDICAP

The Stewards interviewed Karl Kukk regarding an incident in the parade ring where **JERSEY JACK** was led across the centre of the parade ring through a crowd of people. **JERSEY JACK** bucked, resulting in people needing to take evasive action. Mr Kukk explained that it was the horse's first run, he did not want it going out on its own and so it was an attempt to give it a lead out of the parade ring. The Stewards noted his explanation and cautioned him but were clear that any repeat would result in a fine.

The Stewards enquired into interference between **SING SOMETHING**, placed first and **RELAXED BOY** placed third around 1.5 furlongs from home. The Stewards found the interference to be minimal and that it had not improved the placing of the winner. The Stewards found George Rooke, the rider of **SING SOMETHING**, guilty of careless riding cautioned him.

Race 3 - 3.40pm. THE 2019 RAVENSCROFT JERSEY OAKS

Freddie Tett, the rider of **SAFIRA MANINA**, placed second objected to **MOLLIANA** placed first on grounds of interference under Rule (B) 69.2.1. The Stewards reviewed the side on and head on replays and found that no interference had taken place. The objection was therefore overruled and the result allowed to stand.

Race 4 - 4.15pm. LADBROKES LADIES DAY HANDICAP
