Prior to Racing:

The Stewards noted that the results from the routine test of **MAN OF THE SEA**, trained by Neil Mulholland came back negative, the trainer was duly informed.

Celene De La Haye trainer of **BIRKIE BOY**, running in the third, requested that the horse be led in. This was granted on the basis the horse should be in the second row.

Alyson Malzard trainer of **COOL DANDY**, running in the last, requested that the horse be allowed to leave the parade ring early and be mounted on the course. The Stewards granted this request.

The Stewards noted that racecard did not reflect **CAWTHORNE CRACKER**, trained by Oliver Greenall & Josh Guerriero in race one, had in fact declared a tongue tie. They took no further action.

Following an instruction from The Channel Islands Horseracing Authority instructing the Stewards of this meeting to interview Mr F Tett as to why he did not report the reason for the poor performance of **DIPLOMATIE**, in Race 5, as he was required to do under Riders Manual Rule (D) Rule 39.

Mr Tett apologized to the Stewards for the oversight and agreed that he had informed the trainer Alyson Malzard trainer of **DIPLOMATIE**, that the horse had run in snatches and was hanging.

The Stewards noted his explanation and offered some sympathy as the weather at the meeting was not seasonal. They therefore concluded that a penalty of \pounds 120 was to be imposed as was required under the Rules of Racing, but that was to be suspended for the rest of the Channel Islands racing season.

It was brought to the Stewards attention that the ground at or about the 4f marker was potentially 'false'. The Clerk of the Course and a Steward duly inspected the ground, they agreed that the issue was where the drainage groundworks had taken place thus creating a hard stripe across the course. The area both sides of this strip had remained saturated after watering but with drying ground they took no further action.
