Prior to Racing:

The Stewards noted that the results from the routine test of, **ROI DU MONDE**, trained by Alyson Malzard came back negative. The trainer was duly informed.

The Stewards noted that due to the forecast high temperature the time in the Parade Ring would be reduced to 5 minutes before the off and jockeys would be given a 1-2lb discretionary allowance to ensure they remained hydrated throughout the course of the afternoon. The Parade Ring Steward and the Clerk of the Scales were duly informed.

Veterinaries, trainers and grooms were reminded to be mindful of the weather conditions, ensure that horses were cooled effectively and made aware that horses should not be left to stand in hot horse boxes for extended periods of time. All Stewards were reminded to look for signs of heat stress in participants during racing, both equine and human.

The Head of Racing and three Senior Stewards interviewed Mr. Karl Kukk in relation to the incident in the parade ring on the 28^{th} July 2024. Whilst he was highly apologetic, he was left in no doubt as to the seriousness of his actions. It was noted that there had been a further incident but that had been dealt with separately by the Jersey Race Club and was therefore not subject to further enquiry, but it pointed to a pattern that must not continue. He was fined £500 on both matters, so a combined total of £1,000. Mr. Kukk has indicated that he will not be training in the islands next season and thus after deliberation the penalty was suspended until the close of the 2025 racing season.

Karl Kukk requested that in Race 2 **ST OUEN** have a handler with them at the start. Celine De La Haye requested in that **AGAPANTHER** in Race 2 and **NATURE** in Race 3 and **BIRKIE BOY** in Race 4 had handlers at the start.

These requests were granted by the Stewards and both trainers were reminded that in the event the horses were to be lead in it must be from the second row.

Alyson Malzard trainer of **COOL DANDY** requested that the horse go early to the start. A request was made for **TIMETODOCK**, running in the second, also trained by Alyson Malzard, to be last out of the parade ring. Permission was granted on both requests.

The Stewards noted that **LADY AMANDA** trained by Karl Kukk in Race 2 had been correctly declared to wear both a Tongue Tie and Cheekpieces, however the Tongue Tie had been omitted from the race card. The commentator was asked to announce the omission, and no further action was taken.
