The Stewards noted that **MAQUIGNON** did not travel in the race. The Jockey, Victoria Malzard reported that the horse did not lose action but he did not feel right and will have his back checked. The racecourse vet was asked to examine the horse and did not report back to the Stewards.

The Jockeys reported that the 7f bend was slippery and requested that the course is spiked and the issue addressed before the next race meeting.

Post Racing

Following a complaint to the Stewards in relation to an incident in the weighing room prior to the first race. The Stewards interviewed the Clerk of the Course and the Clerk of the Scales. Neither were witness to the incident, CCTV footage highlighted the issue raised by the complainant. The matter was referred up for review and resolution.

The Stewards received a complaint from a Parade Ring Steward in relation to an incident in the parade ring before the fourth race. The Clerk of the Scales reported that a complaint had been received after the conclusion of the days racing from a Jockey in relation to the same incident prior to the Start of the fourth race. Due to both parties having left the course after the conclusion of the day's events the matter will be addressed at the next race meeting on the 30th May 2026 by the Stewards.
