Post Racing

Prior to the last race the Stewards requested that James Moon send his representative to attend an enquiry into his failure to declare a rider for JONCHERE (FR) before noon on the day before racing contrary to of Rule (F)52.3. In addition, Mr Moon had declared two horses with the same colours at declaration stage in the third race in breach of Rule (E)66.3. The nature of the enquiry had been notified to Mr Moon prior to racing.

The Stewards waited until 21:20, half an hour after the last race and no representative was forthcoming. They noted on leaving the Weighing Room that Mr Moon's horse trailer was not on-course. The matter will therefore be deferred and considered before the next meeting. The Stewards ordered that Mr Moon's representative be on course at least 1 hour before the start of the first race to attend the enquiry.
